She then entered De Pauw University from which she graduated in 1909, later taking advanced studies in the Chicago Training School and in Purdue University, After her graduation from DePauw she began her career as a high school teacher holding positions at Montmorenci. Romney, Wea and Brookston, Indiana in a period ending in 1920. In 1922 she became principal of the Boylan Home School for Negro Girls at Jacksonville, Florida, this being one of the mission schools maintained by the Womens Society of Christian Ser vice of the Methodist Church. wShe was thus engaged until 1929. know nothing positive. Last summer while in Eastern Pennsylvania I found a book entitled "American Boyers". In this book I found this record: C.(2) John R., s. of Anthony Bayer and Salome Reinhart, was b. March 19, 1797, probably in New Berlin, Union County, Penn. and d. June 26, 1879 at Salem, Clarion County, Penn. His grave is in Salem, Clarion County, Pa. Blacksmith in Clarion County. Captain of some military organization. In 1818 he m. Anna Maria Shambaugh. Children: Allen, Levi, Neri Amos, Alfred s., Ralph, Matilda, Hettie, Leah, Amelia, Richard and Martin." Following this paragraph were the names, etc., of the children and the spelling was here given as Boyer. As New Berlin, Penn is only a few miles from the home of George Jr. in Snyder County I have thought that the wife of John Boyer in the above account may have been the Mary (Maria) daughter of George Jr. who was supposed to have married a John Boyer. Then, while in Lewisburg, county seat of Union County, Ifound this record at the count house: Last Will and Testament of Elizabeth Piatt: In the name of God, Amen, I, Elizabeth Piatt of the Township of White Deer and County of Union and State of Pennsylvania being weak in body but of sound and perfect mind, memory and blessed be the Almighty God for the same do make and publish this my last Will and Testament in the mather following that is to say, first I give and bequeath, to Isaac, Jacob and John, Leah, Susan and Esther and Rachael's children to have one share amongst them. I do give and bequeath unto my eldest son Samuel's children one dollar, my wearing apparel' is to be equally divided among my three daughters after my decease, my real estate, which is as follows a house and lot of ground in the town of Somerset in Washington Township, Lycoming county. Bounded by the estate of John Piatt Sr. 1823 April 17 Could this by any possible chance be Estate of Hambaugh? I am hoping that this item will bring forth comment or perhaps some one will have correct information on the family of Elizabeth Shambaugh Platte?

Last summer after arriving at Middleburg, Snyder County, Penn., I hied myself immediately to the office of the Middleburg Post. There I met Miss Clara Winey very efficient and most gracious I found her to be. She gave me every assistance possible in my efforts to check the material I already had of the Snyder County Shambachs and gave me many pointers to assist in my future research. I spent parts of two days in the Post office going over files of the papers and other records, but found very little new information there. I called on a number of descendents of George Jr. and was made most welcome. There were many more whom I wished to call on but the time was short and I had to hurry on. Ispent several hours at the court housein Lewisburg, Union County, where I obtained a lot of records. That is where I should have spent more time I realize now for all of the early records were at Lor isburg. The court house closed at noon on Saturday and I felt that I could not possibly stay over longer. I am sorry now tho that I did not take more time. With this War upon us I may not get to go back to Snyder County soon. I had planned to go again in the summer or 1942, going there first and staying, if possible, until I had exhausted all clues to the missing links in the family of George Junior.

In Partonville, which is close to Middleburg (county seat of Snyder County), I called on Harvey Shambach, son of David Shambach and Catherine Stahl-necker Shambach and grandson of Christian Shambach. I found Cousin Harvey most interesting and he seemed quite pleased at the efforts that are being made to collect Shambach data. He is not well, but is a very patient sufferer. Of the early

Snyder Stahlbeginnings he says that there were three or four brothers who came to America from the River Rhine in Germany. He told several anecdotes in connection with the family that Iwish I could remember in full. I believe thathis grandfather, Christian, died in his father's (David's) home. "Cousin Harvey" has never married and has always lived near the old land holdings. He showed me a pair of steelyards (scales) that his grandfather Christian and Stahlneckers used in making whiskey and apple-jack on the Stahlnecker place. Whiskey was sold for 37% a quart. I was sorry to lear that a member of our clan had made intoxicants, but I think perhaps there was more corn grown than was needed for food, with perhaps no sale value and that whisk key was one way of using up the surplus and at the same time bring in a good revenue.

Christian must have been a good man for Cousin Harvey told of seeing his grandfather standing in front of his bureau at bedtime reading his bible. We do not think of the whiskey makers of today as being at all religious, atleast not in this section of country where I live (Tennessee). They are considered bootleggers here and are not accepted socially. Cousin Harvey also had a hatchet that belonged to George Shambach of Bucks County. It was given to him by his grandfather Christian who had received it from the old George I. I do wish I could have visited again with Cousin Harvey for I did enjoy my visit with him so much and I am sure I could have learned a great deal more of the family from him after he had had time to get over the surprise of my visit.

In going to Snyder County I travelled up the beautiful valley and bluffs along the Suguehanna River from Harrisburg. It was a lovely trip and somehow I felt that I was going home. I had always longed to see the early setting of the family in Snyder County and Bucks County also, but when I realized I would soon be there I was quite thrilled. It is indeed beautiful country. I think out ancestors must have been quite brave to make the hazardous trip and settlement in that wildly, beautiful region. The old George Shambach house stood on a hillside overlocking the farm and facing a gap in the positions in the distance. I wonder if it were chosen as a lovely spot only for the home or was there also some shelter or lockout thought of in that location. Crossing the Susquahanna must have been quite a feat. Iam won dering if the proximity of Montgomery County to Philadelphia and high taxes might have been the reason for the family migrating in the sparsely settled section of central Pennsylvania? With a large family, who perhaps wanted to be farmers, perhaps it was thought that in Union County they might find plenty of land for all.

It is interesting to note that in going to the new country that all of George Ir's some seem to have been with him. It is unfortunate that he lived for so short a time after settling in the new country. The same was true of George I. of Bucks County. He had lived just six years after moving into Virginia, where I presume he had gone upon the insistence of his sons. Daniel, Philip and Ludwig who became early settlers in the section with of Williamsburg in Virginia.

I do hope to have more information of the early history of George Shambach I of Bucks County and his family ere long with proof that will clear up and amplify all that we now claim and do hope that any who read this article who may have any information of value along these lines will please send that information on to me or send it to the News-Letter.
