DANIEL SHAMBAUGH'S TILL.... As we have stated in a previous issue, Daniel Shambaughorn in Pennsylvania in 1753, settling in Frederick County, Virginia in 1793 seems to have been the only one of the family who took root and remained in the Shenam doch Valley. We have record of his death in 1837 in a letter passing between two of his sons. Previous to his death, December 26, 1836, he made his will and we have a certified copy of that will in our possession. From it we learn that he was a pen of some considerable possession inasmuch as the executores of that will were to quired later to post a bond in amount of \$26,000.00 In this will he names has ten children beginning with the daughters Mary, Margaret and Bachel who probably cared for him in his old age. Next he names the other two daughters, Ann who married Hammock and Abigail who married Mauck both of whom seem to have borrowed some money from him which fact is also evident with relation to the five sons, John (then deceased), Jacob, Joseph, Benjamin and Daniel. He devotes a special section of his will to his five slaves. These he bequeathed to the three daughters first named with specific instructions as to how each was to obtain his or her freedom.

Tradition has a way of magnifying and distorting the truth. We have head that Daniel had at least thirteen children and that he owned many slaves. We accept this, his last will and testament, as evidence that he had but ten children that reached maturity, and that he was a slave owner. We also have evidence in deeds or record that he owned a great deal of land. The homestead in which he lived and reared his family still stands and is in use and in good repair. Daniel Shambaugh was a Virginia gentleman of considerable consequence and substance.

Permit us to introduce to you..... ARCHIBALD MAJOR SHAMBAUGH? son of Tobey Michael and Leila Constance (Sheppard) Shambaugh who was born January 12. 1885 at Superior, in Nuckells Co.. Nebraska. He received his early education in the rural schools and graduated from the Superior high school in 1903, entering Nebraska Wesleyan from which he graduated in 1907. later taking advanced training at his alma mater and at the University of Montana. He was married Sept. 7, 1918 to M. Faye Thompson, daughter of Alfred H. and Minerva H. Thompson who was born Dec. 31, 1890 at Lincoln, Nebraska, Mr. Shembaugh began his business life as a bank bookkeeper and clerk in his home town of Superior; from that he became a cost accountant and clerk with the Copper Queen Mining Co of Bisbee, Arizons. He tried stock ranching in Nebraska and then became principal and superintendent of a town school in Bebraska. He was a high school instructor in Bisbee. Arizona and has been an instructor in methematics for the past thirteen years in the Seattle high schools. He was an officer in World War I, serving as First Lieut. Calv. with the 348 Machine Gun Battery, 91st Division, He is a Meth. odist am a Republican in politics. In college he was a Phi Kappa Tau. He is a thirty-second degree Mason, a member of the Shrine and the O E S. His home address is 2128 Halleck Ave S W., Seattle, Wash-Geneslogy- Tobey M- James- George-
