Mrs F O Pettit, Norcatur, Hans. tell us- "Since my stay in the hospital at McCook Nebr. in July I am some better but not too well even yet. Twin soms, Dennis James and Dale Lee were born April 1, 1948 to Mr and Mrs Ervin Stephens of Amherst, Nebr she the former Joyce Brunk, daughter of Philip Brunk. My brother John Brunk passed away Oct. 23, 1947. Mrs Margaret (Miller) Jeffery of Oskaloosa, Kans passed away June 26, she was a daughter of Nina Brunk (Mrs Lloyd Miller). There are only four of our family still living." The Brunks are children of Margaret Louise Shambaugh Brunk whose father, Philip William Shambaugh was a son of Isaac Shambaugh of Coshocton, Ohio. We remember with pleasure our meeting with these people in 1941.

MRS CASTLEBERRY S account of her work which began with her Christmas greetings continues as follows- The Philip half of our Lancaster line, the Philip who was bro ther to George II and remained in Pa., has not been completed as it should be. Too much information remains buried in Cumberland County. If Mrs Dick cannot help us at an early dateI hope she can interest some other energetic Shambaugh in our project. The MOUNTY section of that line has been well cared for by Mrs Maude Hervey of 1420 So. Wichita St., Wichita, Kans., whom I visited in 1941, and by Mr. Harold M. Fetterman of 2310 Orange St., Harrisburg, Pa. John Mountz, son of Mary Shambaugh Mountz third child of this Philip of Carlisle, Pa., was grandfather of both. Part of John's big family stayed in Pa., while others settled in Kansas. His 11 children produced a total of 171 already listed. Mrs Hervey's father, Jacob T. Mountz died 3-7-1891 at Wichita; her mother, Ida K. Shuff Mounts died there 4-25-1948 at 86. This Mrs. Mountz was sister to the wife of Levi J. Shambaugh of Carlise, viz., Mary E. Shuff who died in December 1937. The latter was grandmother of Mrs Dick so she am Mrs. Hervoy are doubly related. Mrs Hervey lost her husband 4-11-1947 so she has gone thru a great deal the past years. I am sure a letter from Mrs Dick would be appreciated. One section of which the Rev. You will recall that Mrs Gervin's story is of an Adam Reger whose daughter Ann Katherine married George Shambaugh. The account is from a book by Dr Chas A. Fisher.

Important Says Dr. Fisher: " Prior to 1772, roughly, that part of Snyder County lying south of the Middle Creek was part of Cumberland County. The general section between the Middle and the Mahantango Creeks, and south of the latter was known as " Penn's Manor" and on the other old maps as " Pennsboro". The first tax list of this section was compiled in 1768 and contained twenty-three names showing that not many settlers had located in the section. The part north of Middle Creek belonged to Borks County, Some of the people on the 1768 tax list probably lived in what was then Berks County. In 1772 Northumberland was formed and the southern boundary of the new county, west of the Susquehanna River, was the Mahantango Creek, and what is now Snyder County, except Monroe Township, became in 1772, Pann Township of Northumberland County. The " New Purchase" of lands beyond the mountains was made in 1769 and immediately settlers from the southeastern and eastern sections begen to move beyond the mountains and across the Suscuchanna, in numbers. The tax list of Penn Township for 1772 contained about fifty names and that of 1776 at least three hundred, and although the Indians harrassed the settlers so much that some returned to their old homes, others came on, and pushed up into the Penns, Middle Creek, Mittany and Bald Eagle Valleys, In 1787, the western part of Penn Township was cut off and named Beaver Township, and in 1796 the southern part of Penn Township was formed into Manhantango Township. This new township comprided largely what is today Union, Chapman, Washington, Perry and West Perry Townships. What is today Monroe Township was then part of Buffalo Township, but later became part of Penn and about 1843 became known as Monroe Township. Other townships were formed from time to time from the three townships, Beaver, Penn and Mahantange, which existed prior to 1800, and by 1819 Mahantango had disappeared entirely, becoming Perry, Chapman and Washington.

And now, on page 3 of this issue we will continue with the story of Adam Reger hoping that it will help us to clear up some of the mysteries attached to the early life of the Shambaughs in America. (See next page)

ADAM REGER (also Regar, Reaber, Regor, etc) was born in Gormany on October, 11, 1749 and died on March 17, 1826 near what is now Beaver Springs, Snyder County, Pa. ie is buried by the side of his wife in the cometery there. He was assessed in Perm Township for the first time in 1776, and in 1786, was assessed with 200 acres of land and personalty. In 1789 he was taxed as a resident of Beaver Township. In 1806 he laid out the village of Beaver Springs, which at first was known as 'Adamsburg', from the first name of the founder. In 1790 his family consisted of one male over and one under 16 years, and seven females. His will was probated at Lewisburg, Pa on April 15, 1826 and mentions his wife, Charlotte and their children: Catherine. Margaret (whose first husband was Peter Wagner by whom she had one son-Absalon P. Wagner. Hor second husband was John Lechner), John, Mary, Susanna, Barbara, Eve, Adam Jr., Elizabeth and Magdalena. The last two preceded their father in death. One of his daughters was married to Thomas Youngman of Mifflinburg. It is believed that Adam was a son of Michael Regar, and a brother of Elias and John, who lived in the Same section. Adam served as a private in the companies of Capt. Michael Weaver and Captain John Black of the Northumberland County Militia."

"MICHAEL RECER (Or Regar) was assessed in Perm Township for the first time in 1768 and his name remained on the tax list until 1780 or 1781. In 1788 he was assessed in Dublin Township, Huntingdon County, Pa. It is believed he was the father of Adam, John and Elias, mentioned above. A Michael Regar was a private, 6th Class in Captain Daniel Clapsaddle's Company, 1st Battalion, Cumberland County Militia."

"ELIAS RECER is supposed to have been a son of Michael Reger. His name appeared on the Perm Township tax list for the first time in 1780 and in the next year he was taxed with 50 acres and personal property. In 1789 he lived in Beaver Township, and the next year his family consisted of one male over and two under 16 years, and two females. On June 21, 1793 he was granted a warrant of survey for 400 acres in Northumberland (now Snyder) County. He was a cooper, and in 1820 was living in what is now Snyder County. He was 77 years old at that time, which would indicate that he was born in 1743. In May 1775 he enlisted in Capt. George Nagle's Company, Colonel Thompson's First Rifle Regiment. He participated in the seige of Boston on Long Island in June 1776."

JOHN REGER is supposed to have been a son of Michael Reger, and a brother to Adam and Elias, mentioned above. He was assessed in Perm Township, for the first time in 1778, and in 1786 he was taxed with 150 acres and personal property. In 1793 he was granted a warrant of survey for 25 additional acres. He served as a private in the companies of Captain John Black, Captain John Moll, Captain John Snyder of the Northumberland County Militia, and in the party of Lieut. Jacob Spees of the Northumberland County Rangers. This last service was in May, 1780."

The following records regarding the Reger Families was also compiled by Dr. Charles Fisher.

"Under ! Marriages of Some Pennsylvania Soldiers and Patriots of the Revolutionary Poriod! we find in 1782 that Adam Reger of Snyder County married Charlottee----This from Dr. Fisher's book! Central Pennsylvania Marriages (1700-1896) page 84"

We find under I Letters of Administration! that on Oct. 7, 1801 after the death of Casper Wannemaker letters were granted to Mary Wannemaker and Adam Regar and Sureties were Herman Coerhof and Joseph Romig.! From Snyder County Pioneors, by Dr. Fisher was find that CASPER WANNEMAKER was a resident of Beaver Township before 17-90 and in that year his family consisted of one male over and two under 16 years, and three females. He died and his wife Mary, and Adam Reger were appointed administrators of his estate on Oct. 7, 1801. It is believed that his wife was Adam Reger's daughter."

"Also from ! Abstracts of Snyder County, Probate and Orphans Court Records (1772-1355) under Snyder County Wills, page 38 we find Adam Reger's will, October 10,1824 — April 15, 1826 from Beaver Township and naming wife: Charlotte, Children: Cather ine, Margaret (Mrs Peter Wegner, then Mrs John Lechner) John, Mary, Rachel, Susan, Earbara, Eve, Adam, Elizabeth (dead) Magdalem (dead)."

"On page 44 (same book as above) we find a John Reger's will April 8,1887-Februar 33, 1838 from Beaverton- no heirs mentioned, but perhaps wife Margaret, although this wife may have belonged to Nicholas Minium as it wasn't possible to decide just which person she was the wife of as the three names were run together."

Dr Fisher gives more information on changes in counties and formations in his book on Abstracts, etc and states that "in 1813, what is now Snyder County became a part of the newly formed county of Union, and that in 1855 the southern part of Union County became Snyder County. When this area was part of Cumberland County, Carlisle was the county seat. When it became Northumberland County, the newly formed town of Sunbury, was the county seat. When it became part of Union County, New Berlin was the seat. The present seat of Union County is Lewisburg, and of Snyder Co, at Middleburg, Pa. This was frontier during the Revolution and practically every male between 16 and 60 served in the Rangers, Militia or Continental forces. Most of the early decedents mentioned in it served in the war. "Dr Fisher is an historian and a genealogist."
